Timeline Intro from Ian Sharp with Contributions from Bob Hamilton

- Ian heard a rumour about allotments in Elder Park, which turned out to be false, but in following up found an alternative on the Fairfield Farm / Elder Farm site.
- He worked alone for a few months, suggested LHA put an article about the site project in their newsletter, asking for help from the Community .A group of members began to form
- A welcoming family group was formed, which sadly disintegrated after a couple of successful seasons due to internal politics.
- The garden has been kept going by a band of friendly workers who are fighting their way out of a pit of despond, meanwhile a decision was made to make a fresh start
- The previous groups were dismantled, and a new group Common Good Glasgow formed
- This group is concerned with how the Council manages / uses their assets, the hows and whys of selling assets, identification of assets
- A common response has been "what is in it for me"
- How to turn that into a positive response ie "We should be taking an interest in our community"



Vision

- Does the Elder Farm Project Suffer From Lack of Vision
- What do we want to do with the site
- What do we see happening on the site in 5 / 10 / 15 years from now?
- How can the community maintain / sustain the site?
- Should we be paying rent for a site that was originally given to the community ergo is owned already by the community?
- Historically how much National Land has been appropriated by Families given Care of and Not Ownership of the Land?
- Do we want to be a burden to the already overworked Glasgow City Council Land & Environmental Services / Parks (LES GCC) (all the while hoping to provide much needed public toilet facilities and perhaps worm bins for dog mess 0
- Can we encourage other communities to recover their own Common Good Assets by creating a template / keeping a record for future use – identifying te necessary steps / conditions / etc?

Group members were invited to ask questions / raise issues and discuss possiblities how to preserve Common Good Assets and their benefits of for future generations

Some Results -

How to get more volunteers to help out at Elder Farm

- Ask the Job Center and Back to Work Groups for help
- Under curren conditions this may involve setting us as a registered charity
- Supervision & Health & Safety Issues would apply
- This could be a valid learning experience

Gifts to the Community Are Not Automatically Given Common Good Status

- Are local communities aware of their Common Good Assets
- How to identify Common Good Assets –
- Gifts have to be registered as Comon Good Assets and do not automatically get registered as Common Good Assets
- Fairfield / Elder Farm has not been registered as a Common Good Asset
- There is a move to ammend the title deeds of Fairfield / Elder Farm to allow Social
 Enterprise currently no commerce is allowed as per original deed of gift
